#### 1. Mill Creek - Elevated Floodplain Project

### 3. MS4 PRP Project along the Norfolk Southern Railroad

Previously Reported: The second project for the MS4 PRP (Pollution Reduction Plan) is a vegetated swale along the Norfolk Southern Railroad. Funding will be needed for this project. Rough preliminary costs have the project at \$600,000.

Currently waiting for the required contract documents from the contractors. Upon receiving and reviewing the required contract documents the Notice to Proceed will be issued for each contract.

#### 10. West Side Social Club - 2021 LSA Grants

Our office is proceeding with preparing the plans, specifications and contract documents for the roof replacement.

## 11. 630 Main Street Parking Lot Improvements - 2021 LSA Grant

## 12. 926 Main Sanitary Sewer Lateral Repairs.

# 21. 2023 LSA Grant - Road and Sewer Improvements Project

The application and supporting documentation were submitted with copies sent to State Representative Mike Carroll and State Senator Martin Flynn. The grant application requests \$963,655.00 for street improvements to the following street:

- 1. Wood Street (from Hawthome St. to Spruce St.)
- 2. Plane Street (from William St. to the Interstate 81 overpass)
- 3. Vine Street (from Main St. to William Street)
- 4. Campbell Street (from Dawson St. to 1396 Campbell)
- 5. Gedding Street (from McAlpine St. to Park Dr.) This also include the sanitary sewer repair from McAlpine Street to 206 Gedding Street.

## 22. 2023 LSA Grant - New Emergency Rescue Truck

The application and supporting documentation were submitted with copies sent to State Representative Mike Carroll and State Senator Martin Flynn. The grant application requests \$1,289,344.00 for a New Emergency Rescue Truck.

## 23. 2023 LSA Grant - New Police Vehicle

The application and supporting documentation were submitted with copies sent to State Representative Mike Carroll and State Senator Martin Flynn. The grant application requests \$65,804.00 for a New Police Vehicle.

# 24. 2023 LSA Grant - North East Pennsylvania Land Bank

Our office prepared a budget for the project and forwarded it to the North East Pennsylvania Land Bank. The North East Pennsylvania Land Bank handled the rest of the application and submission to DCED for the grant. The grant is requesting \$500,000 for acquisition, demolition, environmental remediation, construction, rehabilitation and professional services.

#### 25. 709 Grove Street Driveway Permit

A driveway permit application was submitted for 709 Grove Street. Our office has reviewed the submission and recommends approval with the condition the proposed work maintains the existing curb/sidewalk reveal at the street's pavement edge. Council also needs to approve the driveway permit.

#### 26. 402 Packer Street Driveway Permit

A driveway permit application was submitted for 402 Packer Street. Our office has reviewed the submission and recommends approval with the condition the proposed work maintains the same pipe size as the existing pipe. Council also needs to approve the driveway permit.
