Sealed proposals will be received by the Secretary of the Borough of Avoca, at the Avoca Borough Municipal Building, 950 Main Street, Avoca, PA 18641, Monday through Friday, 9:00 A.M. to 3:00 P.M., until Tuesday, October 11, 2022, at 3:00 P.M., for the collection of garbage and trash within its boundaries. The proposal will be for a three (3) bag maximum per week. A PER BAG EXTRA MUST BE BID AT AN ADDITIONAL COST PER BAG.

- A. For a one (1) year period beginning February 1, 2023 and terminating January 31, 2024.
- B. For a two (2) year period beginning February 1, 2023 and terminating January 31, 2025.
- C. For a three (3) year period beginning February 1, 2022 and terminating January 31, 2026.

Alternate I - Collection of non-freon bulk items on an as needed basis.
Bid 1, 2 or 3 year basis.

Alternate II - Household items collection one (1) time annually. All expenses paid by hauler.
