Previously Reported: Our office has revised the Annual MS4 Status Report as per DEP's comments and has forward a copy to them. We are also currently with working Attorney Boyd on adopting a new stormwater ordinance as required by DEP. DEP is also requesting more Public Education and Outreach (MCM 1) and more Public Participation/Involvement (MCM 2) during each reporting year. In addition, they are also asking for more investigation into sources of Acid Mine Drainage (AMD) and priority organics in Avoca Borough. Finally, DEP stated in their comment letter that they are concerned that Avoca Borough is not showing adequate progress in order to meet their Pollutant Reduction Plan.

#### 4. MS4 PRP Project along the Norfolk Southern Railroad

No new information to report.

Previously Reported: The second project for the MS4 PRP (Pollution Reduction Plan) is a vegetated swale along the Norfolk Southern Railroad. Funding will be needed for this project. Rough preliminary costs have the project at \$600,000.
