# 1. Mill Creek – Elevated Floodplain Project

Still waiting to receive the maintenance requirements for the project from DEP.

## 2. Mill Creek Flood Protection Project

No new information to report.

#### 4. MS4 PRP Project along the Norfolk Southern Railroad

No new information to report.

Previously Reported: The second project for the MS4 PRP (Pollution Reduction Plan) is a vegetated swale along the Norfolk Southern Railroad. Funding will be needed for this project. Rough preliminary costs have the project at \$600,000.

#### 5. McAlpine Street Storm Sewers

No new information to report.

Previously Reported: The McAlpine Street Storm Sewers (both east and west of Mill Creek) tested for high amounts of fecal coliform. Both storm sewers will need to be investigated for the source(s) the fecal coliform.

## 6. Lampman and Gedding Streets Drainage Issues

# 7. Main and McAlpine Streets Intersection Improvements

2019 Penn DOT Multimodal Transportation Grant amount \$1,550,000 2020 CFA Multimodal Transportation Grant amount \$325,000

Penn DOT has suggested for Avoca Borough to apply for a grant through the Automated Red Light Enforcement (ARLE) Transportation Enhancements Grant Program to cover the cost of the Norfolk Southern's fees and the cost of the construction inspection. These costs are estimated to be \$152,200. A Pre-Application Scoping Form was due and was submitted by April 30<sup>th</sup>. The application period is from June 1<sup>st</sup> to June 30<sup>th</sup>. Our office estimates the cost to complete and submit the application to be \$1,500.

# 8. 2019 PA Small Water and Sewer Grant McAlpine Street Storm Sewer Project

The televising of the sanitary sewer on South Street revealed a break in the sanitary sewer due to a gas service line. UGI repaired the sewer main earlier this week. All American Rooter will need to come back to flush the line and cut out some tree roots.

Stafursky is currently waiting for utility conflicts to be rectified.

# 9. Fire and Ambulance Building - 2021 LSA Grants

Construction is progressing and the second payment reimbursement is being processed.

Pennsy Supply, Inc. has submitted the required contract documents and the Notice to Proceed will be issued shortly. Due to the lower than anticipated bid prices, our office requested approval to re-include Wood Street from Hawthorne Street to Spruce Street. DCED has approved this request.
