## 1. Mill Creek Flood Protection Project

Our office is proceeding with updating the Emergency Action Plan as required by DEP.

# 3. MS4 PRP Project along the Norfolk Southern Railroad

No new information to report.

Previously Reported: The second project for the MS4 PRP (Pollution Reduction Plan) is a vegetated swale along the Norfolk Southern Railroad. Funding will be needed for this project. Rough preliminary costs have the project at \$600,000.

# 4. McAlpine Street Storm Sewers

No new information to report.

Previously Reported: The McAlpine Street Storm Sewers (both east and west of Mill Creek) tested for high amounts of fecal coliform. Both storm sewers will need to be investigated for the source(s) the fecal coliform.

#### 5. Lampman and Gedding Streets Drainage Issues

#### 6. Main and McAlpine Streets Intersection Improvements

2019 Penn DOT Multimodal Transportation Grant amount \$1,550,000 2020 CFA Multimodal Transportation Grant amount \$325,000

The project has incurred \$7,241.84 for Norfolk Southern Railway's design work. PennDOT is requesting cancelled checks or an explanation why they are not included. Avoca Borough would need to pay the incurred cost in order to obtain cancelled checks.

#### 10. 2024 COVID-19 ARPA Grant – Community Center Renovations
